Adopted on April 19, 1983

WHEREAS, her successor, Gloria McColl has now been selected by Council, thereby filling the vacancy in District 3; and

WHEREAS, as a result of Ms. Golding's departure and Ms. McColl's appointment, various changes in assignments to Standing Council Committees are necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to section 22.0101, as amended, of the Municipal Code of The City of San Diego, the following appointments by the Deputy Mayor, and changes as indicated, to Council committees for a term expiring December 4, 1983, be and the same is hereby confirmed:

Councilman Dick Murphy to vacate Transportation & Land Use Committee.

Councilman William Jones to assume position of Vice-Chairman of the Public Facilities and Recreation Committee, replacing Councilman Mike Gotch.
