filed in the office of the City Clerk of the City of San Diego, California, on April 25, 1983, and bearing official Document No. W.O. 148164, be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CONSTRUCTION OF RANCHO BERNARDO 20-INCH WATER MAIN ENCASEMENT.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$131,248.00 from Water Revenue Fund 41502, Unallocated Reserve 70679 to Water Operating Fund 41500, Water Main Maintenance Program 70530.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$131,248.00 from Water Operating Fund 41500, Water Main Maintenance Program 70530 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
