WHEREAS, STEPHEN H. CLARKSON, ET AL, have requested an exchange of sewer access easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the acceptance by the City Manager of those deeds of STEPHEN H. CLARKSON, ET AL, executed in favor of The City of San Diego, bearing date of February 4, 1983, conveying to said City a sewer access easement in a portion of Lots 12 and 14 of La Jolla Kirjah Park, Map 8192, as more particularly described in said deeds, copies of which are on file in the office of the City Clerk as Document Nos. RR- 258317-1 and RR- 258317-2, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258317-3, quitclaiming to STEPHEN H. CLARKSON, ET AL, all of the City's right, title and interest in the sewer access easement in Lot 13 of La Jolla Kirjah Park, Map No. 8192,

as more particularly described in said deed.

3. That the City Clerk shall cause the deeds, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
