RESOLUTION NUMBER R- **258319**

Adopted on APR 25 1983

WHEREAS, the Salary Setting Commission (herein called "Commission") of The City of San Diego, pursuant to Sections 24.1 and 41.1 of the Charter, conducted extensive research and held a series of public hearings for the purpose of ascertaining facts sufficient to establish salary levels for recommendation to the Mayor and Council for adoption by ordinance for fiscal year 1983 and 1984; and

WHEREAS, pursuant to the Charter requirement, the Commission is required to present its recommendations to the Council in public hearing on or before February 15 of every even year; and

WHEREAS, the Commission presented its recommendations as required on February 9, 1982; and

WHEREAS, the Commission recommended a two-step increase in annual compensation for the Mayor and Council, the first to be established and incorporated in the fiscal year 1983 Salary Ordinance, to be effective July 1, 1983 and the second step to be established and incorporated in the fiscal year 1984 Salary Ordinance, to be effective July 1, 1983; and

WHEREAS, the City Council adopted the full and final recommendation of the Salary Setting Commission by Ordinance No. O-15681 (New Series), on March 29, 1982, approving therein both steps to be effective on the appropriate dates; and


WHEREAS, it was further directed in Ordinance No. 15681 (New Series) to incorporate the second incremental step in the fiscal year 1984 Salary Ordinance; and

WHEREAS, it was determined at that time that the second step adjustment for the Mayor and Council recommended by the Salary Setting Commission be brought back to Council for review prior to July 1983; and

WHEREAS, the City Attorney was directed to bring forward to the City Council, the matter of the Commission's second step recommendations for review prior to promulgation and incorporation in the fiscal year 1984 Annual Salary Ordinance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation of the Salary Setting Commission for a second step adjustment for the Mayor and Council to \$42,000 and \$30,000 respectively, approved and adopted by Ordinance No. O-15681 (New Series), to be effective July 1, 1983, has been reviewed and the same is hereby acknowledged.
