WHEREAS, CALTRANS has proposed a highway project which includes the construction of State Route 54 between Interstate 5 and Interstate 805, widening of portions of Interstate 5, and a flood control project; and

WHEREAS, a final EIS for the State Route 54 project has been prepared which includes significant project mitigation and enhancement; and

WHEREAS, SANDAG has approved construction of the State Route 54 project in the 1980 Regional Transportation Plan and in the 1982 Regional Transportation Improvement Program; and

WHEREAS, the State Route 54 project will provide an alternate route to the heavily congested State Route 94 freeway which is within the City of San Diego; and


WHEREAS, the freeway agreements between the State of California and the affected jurisdictions for the State Route 54 project have been in effect since 1967; and

WHEREAS, the construction of the State Route 54 project will reduce accidents, improve air quality, and reduce energy consumption; NOW, THEREFORE,

that this Council hereby supports the early construction of the
State Route 54 project between Interstate 5 and Interstate 805.
