

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,114,243.00 from CIP No. 29-479, MARTIN LUTHER KING COMMUNITY PARK - Development, Phase II of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
