Janet L. Eggleston	Property	\$ 1,590	Ms. Eggleston is an Administrative Aide I at Mt. Hope Cemetery. One year ago she earned a partial award of \$25 for her suggestion to notify individuals by mail when their grave lot reservation has expired. One year's experience has shown an increase in revenue of \$5,375. This is the remainder of her award.
Robert C. Hauptman	General Services	\$ 1,460	Mr. Hauptman is a Refrigeration Mechanic in the Buildings Division. He suggested the installation of the hot gas valve on the air conditioning chiller. This is expected to save \$5,375 in the first year in equipment costs.
Earl E. Soladay	General Services	\$ 1,045	Mr. Soladay is an Equipment Mechanic in the Equipment Division. One year ago he earned a partial award of \$1,045 for his suggestion to rebuild the detent section of the Dempster Packer control valve. One year's experience has shown a savings of \$6,965. This is the remainder of his award.
John R. Crowell	Police	\$ 690	Mr. Crowell is an Evidence Technician. He suggested replacing the current brand of fingerprint tape with 3M 80 brand which is less expensive. This is expected to save \$2,302 in the first year in material costs.
