That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Stephen C. Holmes	Fire	\$450	Mr. Holmes is an Equipment Repair Supervisor. He suggested that the Raycor primary fuel filter be replaced with a Fleetguard spin-on fuel filter. This is expected to save \$2,993 in the first year in time and material costs. This is a partial award pending a final 12 month review.
Warren J. Geiske	Fire	\$130	Mr. Geiske is a Firefighter. He suggested simplifying the installation of door controllers in fire apparatus cabs. This is expected to save \$869 in the first year in material and equipment costs. This is a partial award pending a final 12 month review.
Ronald R. Williams	Fire	\$ 80	Mr. Williams is a Fire Captain. He suggested that two wooden wheel blocks be used on the fire apparatuses. This is expected to save \$554 in the first year in equipment costs.
Remdios A. Jacinto	Citizens Assistance	\$ 50	Ms. Jacinto is a Senior Stenographer. She suggested that the public be provided with information and instruction forms for business licenses. Although savings were difficult to identify, this was considered to be a significant operational improvement.
