Arthur F. Robertson	Fire	\$ 40	Mr. Robertson is a Fire Captain. He suggested that a fee be charged for providing records that are subpoenaed. Actual revenue for the first year was \$422.
Douglas S. Bauer	Fire	\$ 25	Mr. Bauer is a Fire-fighter. He suggested that an air bottle with pressure between 300-500 PSI be carried on Utility rigs to test low pressure warning bell on breathing apparatus. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
