BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CONSTRUCTION OF COLLEGE AVENUE DRAIN ROCKHURST DRIVE TO 450 FEET NORTHERLY.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245, \$8,100.00 from CIP No. 58-004, MISCELLANEOUS IMPROVEMENTS ON CITY STREETS to CIP No. 11-194, COLLEGE AVENUE DRAIN.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$62,100.00 from Capital Outlay Fund 30245, CIP No. 11-194, COLLEGE AVENUE DRAIN of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
