RESOLUTION NUMBER R- 258379

Adopted on MAY 2 1983

WHEREAS, a certain drainage easement was acquired for an earlier development within the subdivision known as Van Caster, Map 8364; and

WHEREAS, said easement is no longer needed and the present development of the property requires the quitclaiming of said easement; and

WHEREAS, a flowage easement has been acquired over a portion of the drainage easement being abandoned; and

WHEREAS, the drainage easement was acquired at no cost and VAN DERSTEEN ENTERPRISES, a general partnership, has paid all City costs in connection with processing the matter of quitclaiming the easement; and

WHEREAS, the processing costs of the abandonment will be the consideration for the sale of the City's rights; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258379 -1 , quitclaiming to VAN DERSTEEN ENTERPRISES, a general partnership, all the City's right, title and interest in the drainage easement, as more particularly described in said quitclaim deed.

2. That the City Clerk of said City be, and he is hereby authorized and directed to cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
