BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a one (1) year Use and Occupancy Permit, beginning May 16, 1983, with ASSOCIATED SPORTS PROMOTIONS COMPANY, which Permit gives Associated Sports Promotions the opportunity to conduct tours of San Diego Jack Murphy Stadium, and under which Permit City shall receive twelve percent (12%) of all gross revenue against a minimum annual consideration of \$1,000, whichever is greater, under the terms and conditions set forth in that Use and Occupancy Permit on file in the office of the City Clerk as Document No. RR- 258385.
