WHEREAS, Sections 8330 et seq. of the Streets and Highways Code provide a procedure for the summary vacation of an excess right-of-way of a street or highway not required for street or highway purposes; and

WHEREAS, the abutting property owner has requested the vacation of portions of Juniper and Gregory Streets adjacent to Lots 1 and 8-12, Block 46, of Eastern Addition, Map 295, within the proposed Sleepy Hollow Subdivision (TM 82-0737) boundaries, to facilitate development of his property; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That those portions of Juniper and Gregory Streets adjacent to Lots 1 and 8-12, Block 46, of Eastern Addition, Map 295, as more particularly shown on Drawing No. 15507-B on file in the office of the City Clerk as Document No. RR- 258389-/

which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

- 2. That the resolution shall not become effective unless and until the final subdivision map for the Sleepy Hollow Subdivision (TM 82-0737) has been approved by Council action. In the event that the final map is not approved by December 29, 1984, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.




