RESOLUTION NUMBER R- 258390

Adopted on MAY 2 1983

WHEREAS, Sections 8330 et seq. of the Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where a portion for a street or highway lies within property under one ownership and does not continue through such ownership or end touching property of another; and

WHEREAS, the abutting property owners have requested the vacation of "L" Street adjacent to Lot 6, Block 72, and Lot 1, Block 71, all of San Diego Homestead Union, Map 363; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That "L" Street adjacent to Lot 6, Block 72, and Lot 1, Block 71, all of San Diego Homestead Union, Map 363, as more particularly shown on Drawing No. 14922-B, on file in the office of the City Clerk as Document No. RR- 258390, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

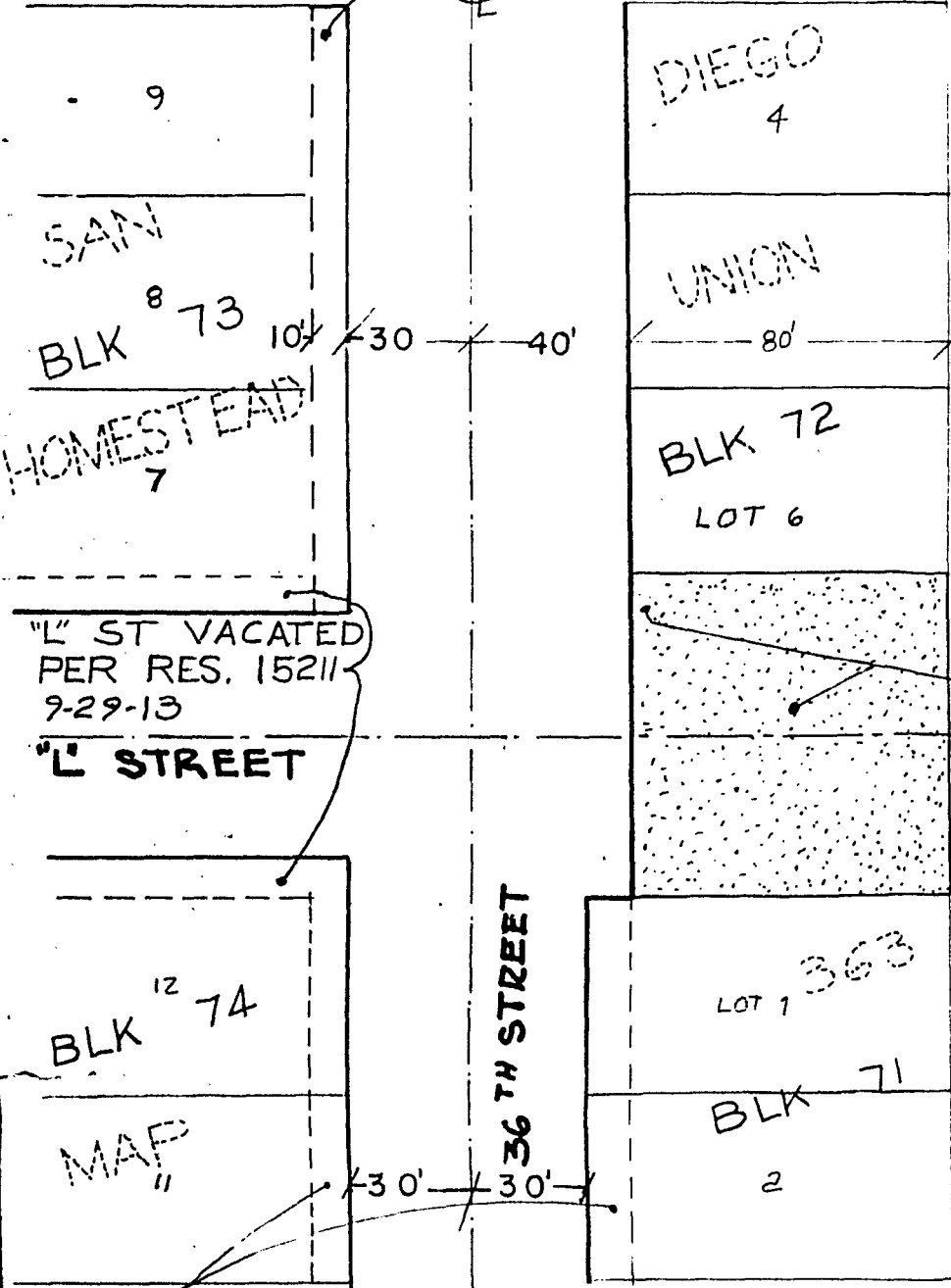
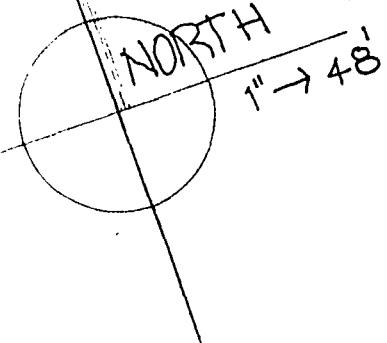
2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

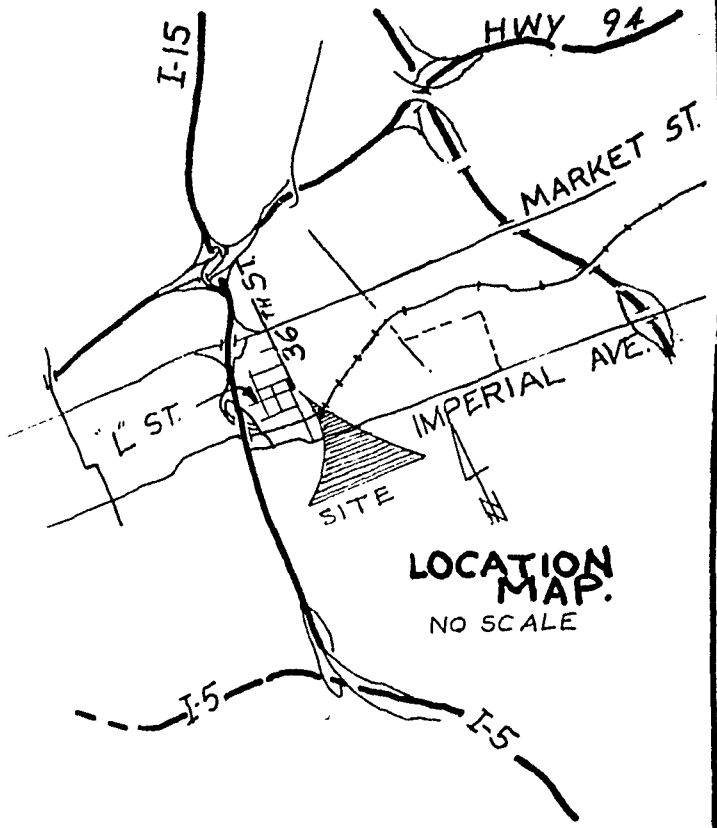

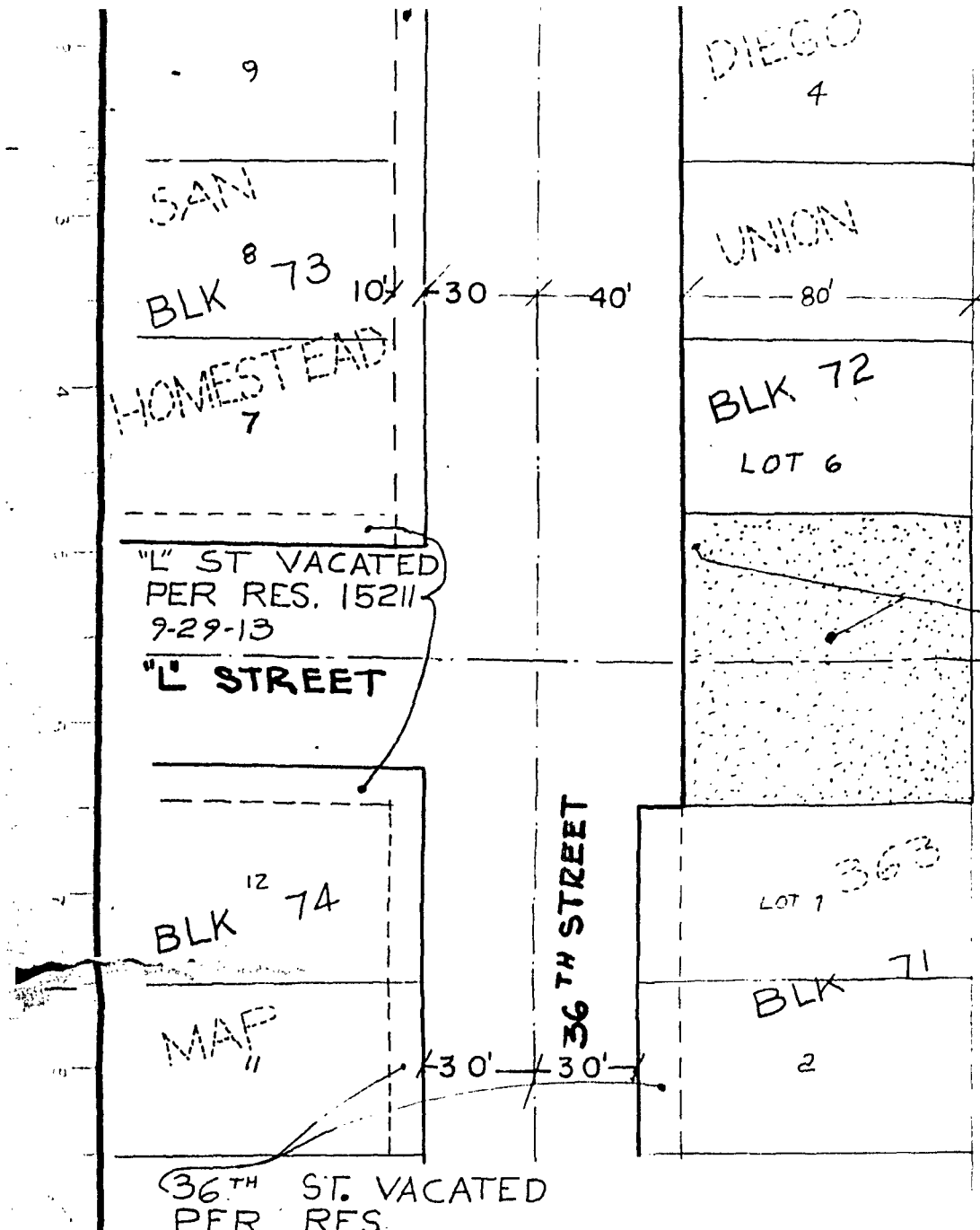

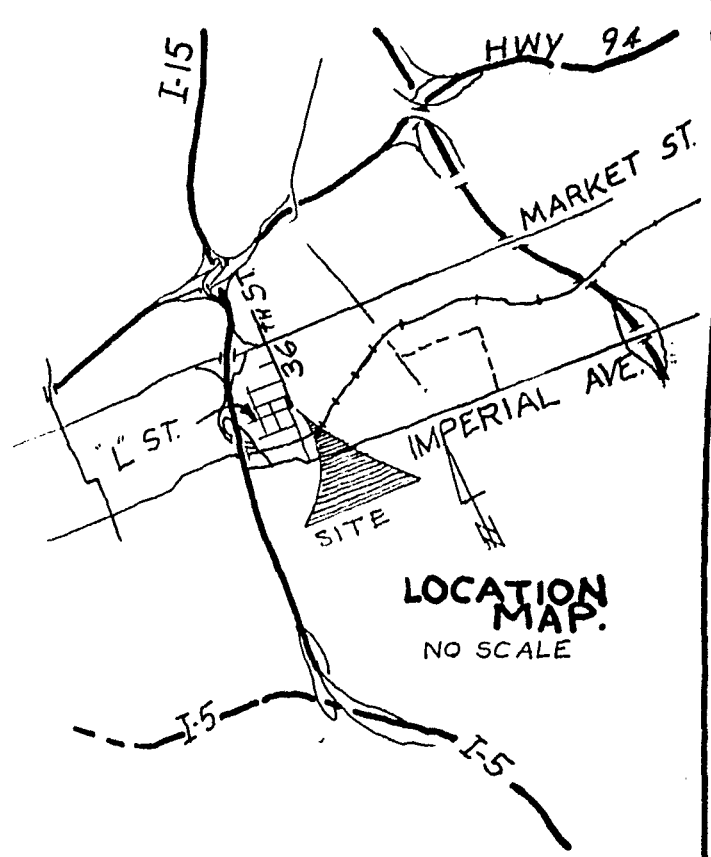
