Be it resolved, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to pay the total sum of \$250,000.00 in the settlement of Superior Court Case No. 450602, John L. Stiscak v. Patricia Lee Mozzochi, City of San Diego, et al., and of each and every claim against The City of San Diego, its agents and employees, resulting from the personal injury to John L. Stiscak.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue a warrant check, in the amount of \$250,000.00, made payable to JOHN L. STISCAK, BY AND THROUGH HIS CONSERVATOR, JAMES L. STISCAK, AND HIS ATTORNEY SALVADOR A. LICCARDO, in full settlement of the lawsuit and of all claims.
