

**RESOLUTION No.** R-258397 (R-83-1632)



2. That the City Auditor and Comptroller is hereby authorized to transfer \$21,000.00 from Capital Outlay Fund 30245, CIP No. 90-245, Unallocated Reserves to CIP No. 62-227, TORREY PINES ROAD FROM ARDATH LANE TO GLENBROOK WAY/DUNAWAY DRIVE.

That the expenditure, not to exceed \$21,000.00 from Capital Outlay Fund 30245, CIP No. 62-227, TORREY PINES ROAD FROM ARDATH LANE TO GLENBROOK WAY/DUNAWAY DRIVE of the City of San Diego is hereby authorized to supplement funds previously authorized by Resolution No. R-257892, adopted on February 7, 1983.
