APPROVING MAP OF EAST BLUFFS

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by William Gregory Clarke, a licensed Land Surveyor, entitled "EAST BLUFFS, being a subdivision of Lots 210 and 211 of Eldorado Hills, Unit No. 8, in The City of San Diego, County of San Diego, State of California, according to the Map thereof No. 9295, filed in the office of the County Recorder of San Diego County on July 20, 1979, and Lots 212 and 213 of Eldorado Hills Unit No. 9, in The City of San Diego, County of San Diego, State of California, according to Map thereof No. 9366, filed in the office of the County Recorder of San Diego County on September 17, 1979, together with Cascada Way, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space over, under, upon and across Lots 85 and 86, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to

endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that the open space easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
