WHEREAS, the Tax Equity and Fiscal Responsibility Act of 1982 (TEFRA) amended Section 401(a)(9)(B) of the Internal Revenue Code in a manner which affects public pension plans; and

WHEREAS, the amendment specifically requires that when a plan participant is killed as a result of a line of duty death, if the beneficiary is someone other than a spouse, the entire annuity must be paid out within five years; and

WHEREAS, this conflicts with the City's current retirement provisions which permit payouts to surviving children until they reach age 18; and

WHEREAS, on April 18, 1983, the Rules Committee considered the analysis and recommendations of the Intergovernmental Relations Department (IRD) contained in Report No. 83-21 regarding a further amendment to the federal tax laws; and

WHEREAS, the Rules Committee approved said recommendation and submits it to the full Council for its approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Intergovernmental Relations Department be directed to pursue an amendment to Section 401(a)(9)(B) of the Internal Revenue Code with the Joint Tax Committee and the Treasury

Department for the purpose of correcting the problem described in the IRD Report No. 83-21, dated March 29, 1983.
