RESOLUTION NUMBER R- 258436

Adopted on MAY 9 1983

WHEREAS, on December 10, 1982, Assemblyman Moore, Hughes and Harris introduced Assembly Bill 96 (AB 96); and

WHEREAS, as presently amended, the bill would add Section 647e to the California Penal Code authorizing cities to adopt ordinances regulating the possession of open alcoholic beverage containers on certain posted premises; and

WHEREAS, the public continues to express concern about the problem associated with loitering and alcohol consumption around liquor and convenience stores; and

WHEREAS, existing state law preempts local regulation of possession of alcohol; and

WHEREAS, AB 96 would provide a useful tool for reducing illegal activities around liquor and convenience stores; and


