BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, at his option, to utilize an Irrevocable Letter of Credit, in the form on file in the office of the City Clerk as Document No. RR- 258440- $\beta$ , in lieu of paying cash pursuant to the above-described Purchase Agreement.
