SECTION 1. That the above recitals are all true and correct.

SECTION 2. That the City Council hereby rejects all of said proposals or bids except that herein mentioned, and does hereby award the construction contract for doing said work and making improvements in the Assessment District to the lowest responsible bidder, to-wit:

M. ARRIETA & SON, INC.

at the prices named in the bid of said bidder with the transcript of these proceedings and open for public inspection.

SECTION 3. That this award of contract is hereby conditioned upon and made subject to the receipt of monies from the sale of bonds.

SECTION 4. That the works of improvement shall be constructed in the manner and form as set forth in the plans and specifications for these proceedings, as previously approved as a part of the "Report", as required by law and specifically the "Municipal Improvement Act of 1913", being Division 12 of the Streets and Highways Code of the State of California.

SECTION 5. That the Mayor and City Clerk are hereby authorized to execute the Agreement for the works of improvement relating to said Assessment District for and on behalf of the City, and a copy of said Agreement shall be on file with the transcript of these proceedings.
