WHEREAS, Senate Bill 48, urgency legislation authorized by Senator Rose Ann Vuich, would postpone for three years, for additional study purposes, the June 15, 1983, effective dates of new Rules 15 and 16 of the Public Utilities Commission; and


WHEREAS, new Rules 15 and 16 require that effective June 15, 1983, all off-site reinforcement of existing utilities be paid by the applicant, rather than by San Diego Gas & Electric as is the current practice; and

WHEREAS, the Centre City Development Corporation has requested that the City support Senate Bill 48; and

WHEREAS, on April 11, 1983, the City Council adopted Resolution No. R-258216 taking no position with regard to Senate Bill 48; NOW, THEREFORE,

BE IT RESOLVED, by the City Council that the City hereby reaffirms its "no position" stance regarding Senate Bill 48.
