

BE IT FURTHER RESOLVED, that the combined total expenditure, not to exceed \$151,800.00 as follows: \$11,622.95 from Fund 18513, Dept. 8635, Org. 8636; \$109,466.74 from Fund 18514, Dept. 7380, Org. 7381; \$23,210.31 from Fund 18515, Dept. 5940, Org. 5941; and \$7,500.00 from Capital Outlay Fund 30245, CIP No. 58-007 OVERHEAD AND OTHER CITY COSTS FOR PROJECTS FUNDED BY FEDERAL GRANTS, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
