RESOLUTION NUMBER R- 258484

Adopted on MAY 23 1983

WHEREAS, with the filing of Collegiate Park Subdivision Map No. 5006 there were relinquished to The City of San Diego certain vehicular access rights in and to Genesee Drive and Executive Drive, adjacent and contiguous to a portion of Eastgate Mall (Parcel 2 of Parcel Map 4967); and

WHEREAS, the Property Department has requested that the City revest these vehicular access rights in the property to allow better utilization of the land; and

WHEREAS, said vehicular access rights are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said access rights; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That those certain vehicular access rights in and to Genesee Avenue and Executive Drive adjacent and contiguous to a portion of Eastgate Mall (Parcel 2 of Parcel Map 4967), as more

particularly described in the legal description attached hereto as Exhibit A and by this reference incorporated herein, be and they are hereby revested into said property.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

EXHIBIT A

LEGAL DESCRIPTION

All those certain abutters' rights of access in and to Genesee Avenue and Executive Drive (formerly Miramar Street) adjacent and contiguous to Parcel 2 of Parcel Map 4967, filed in the Office of the County Recorder of San Diego County, State of California, as File No. 76-247398, on August 3, 1976; said Parcel Map being a division of a portion of Lot 2 of Collegiate Park according to Map thereof No. 5006, filed in said Office of the County Recorder on July 3, 1962; said abutters' rights having been reserved to the City of San Diego by the Filing of said Map No. 5006, more particularly described in three parcels as follows:

Parcel 1

The Southerly 30 feet of the Northerly 60 feet of said abutters' rights of access in and to Genesee Avenue adjacent and contiguous to said Parcel 2 of Parcel Map 4967.

Parcel 2

The Easterly 21 feet of the Westerly 300.23 feet of said abutters' rights of access in and to Executive Drive adjacent and contiguous to said Parcel 2 of Parcel Map 4967.

Parcel 3

The Easterly 30 feet of the Westerly 553.23 feet of said abutters' rights of access in and to Executive Drive adjacent and contiguous to said Parcel 2 of Parcel Map 4967.
