

RESOLUTION NO. R- 258493 (R-83-1655)Adopted on MAY 23 1983

WHEREAS, continued economic growth in San Diego County and Southern California requires the existence of a reliable, adequate supply of energy;

WHEREAS, the opportunity for the development of future energy projects depends on the existence of suitable sites;

WHEREAS, such a site, owned by San Diego Gas & Electric, now exists near Blythe, California, along with contracts for sufficient water supplies to support a generating plant, such site and water supplies constituting a unique and valuable regional resource which could not be replaced except at a disadvantageous price; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Council of The City of San Diego supports the retention and preservation of the Blythe site for development of an electrical generation powerplant to provide electrical energy to the Southwest in the future, and urges the California Public Utilities Commission to encourage the preservation of the site for such future energy development.

BE IT FURTHER RESOLVED, that the issues of inclusion of the site in the ratebase will be decided in the public hearing process before the Public Utilities Commission.
