RESOLUTION NUMBER R- 258495

Adopted on MAY 23 1983

WHEREAS, Sections 8330 et seq. of the Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where a street has been superceded by relocation; and

WHEREAS, the abutting property owner has requested the vacation of Elmhurst Drive adjacent to Lots 11 and 12 of Resubdivision of Del Cerro Shores Unit 1 Subdivision, Map 10593, to facilitate development of his property; and

WHEREAS, those properties adjoining the streets to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and


WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Elmhurst Drive adjacent to Lots 11 and 12 of Resubdivision of Del Cerro Shores Unit 1 Subdivision, Map 10593, as more particularly shown on Drawing No. 15746-B on file in the office of the City Clerk as Document No. RR- 258495 , which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
