WHEREAS, M. L. Chilcote, an unmarried man, has requested an exchange of water easements; and

WHEREAS, the City Manager has accepted on behalf of The City of San Diego, pursuant to authority conferred by Resolution No. 250320 adopted October 1, 1979, that deed of M. L. Chilcote, an unmarried man, executed in favor of The City of San Diego, bearing the date of March 25, 1983, conveying to said City an easement for water purposes in Lot 11 of Resubdivision of Del Cerro Shores Unit 1 Subdivision, Map 10593, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. F-1838; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are approximately equal; and

WHEREAS, the easement acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258497 - 1, quitclaiming to M. L. CHILCOTE, an unmarried man, all of the City's right, title and interest in the water

easement in Lot 11 of Resubdivision of Del Cerro Shores Unit 1
Subdivision, Map 10593, as more particularly described in said
quitclaim deed.

2. That the City Clerk shall cause the deed and a
certified copy of this resolution, attested by him under seal,
to be recorded in the office of the County Recorder.
