WHEREAS, The City of San Diego ("City") and Medevac, Inc. ("Medevac") entered into an Agreement for the provision of paramedic services ("Agreement") in the City of San Diego; and

WHEREAS, City has issued a request for proposals to implement a Kansas City/Tulsa System Design ("System") for the provision of paramedic services that utilizes variable staffing and variable locations of paramedic units to reduce design costs, yet maintain high levels of service; and

WHEREAS, City and Medevac are currently negotiating a oneyear extension to the Agreement to implement the variable staffing and variable locations System; and

WHEREAS, it is necessary for Medevac to purchase the necessary computer hardware and to develop the necessary computer software to implement a variable location/variable staffing paramedic program commencing on October 1, 1983; and

WHEREAS, Medevac has informed the City Manager that the acquisition for The City of San Diego's paramedic program of the necessary hardware and software for a Fluid Paramedic system can be accomplished for approximately \$79,000 and can be purchased out of presently budgeted funds for the Fiscal Year 1983 Budget; and

WHEREAS, paragraph 6.a.(3) of the Agreement provides for the revision to Medevac's budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,

that Medevac is hereby authorized to revise the Fiscal Year 1983 Budget to acquire for The City of San Diego's paramedic program the necessary hardware and software to implement a variable location/variable staffing paramedic program commencing on October 1, 1983 at a cost not to exceed \$80,000.

BE IT FURTHER RESOLVED, that the expenditure for said computer hardware and software will be from the current year (Fiscal Year 1983) appropriation for contractual paramedic services.
