BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of DONALD L. BREN COMPANY, executed in favor of The City of San Diego, bearing date of March 14, 1983, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 258510, granting to said City an easement for public street purposes affecting portions of Parcels 1, 2 and 3 of Parcel Map No. 10518, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and Parcel "A" is hereby named CHARMANT DRIVE, Parcel "B" is hereby named LA JOLLA COLONY DRIVE, Parcel "H" and Parcel "Q" are hereby named PALMILLA DRIVE and Parcel "M" is hereby named REGENTS ROAD.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
