APPROVING MAP OF GENESEE EAST

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Robert G. Shoettmer, a licensed surveyor, entitled "GENESEE EAST, being a subdivision of a portion of Pueblo Lot 1212 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which is filed in the office of the County Recorder of said county, November 14, 1921, and is known as Miscellaneous Map No. 36, which lies Easterly, Southeasterly, and Southerly of the Easterly, Southeasterly, and Southern line of Clairemont Mesa South Unit No. 1, according to Map thereof No. 4800, and Northeasterly of the Northeasterly line of Cambridge Colony Unit No. 1, according to Map thereof 9260, and Lots 332 through 403 of Cambridge Colony Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 9260, filed in the office of the County Recorder of San Diego County, June 27, 1979, together with Mt. Albertine Avenue, Amboy Avenue, Thornwood Street, and the unnamed alley as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and

accepted; and said Council hereby accepts on behalf of the public, the following: Boyd Avenue, Earnscliff Place and Thornwood Street; and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication that portion of Lot 6 marked "Reserved for Future Streets," as shown on this map, under the provisions of Section 66440 of the Government Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Genesee Avenue, adjacent and contiguous to Lots 2, 4, 5 and 7, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities and slopes, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space over, under, upon and across Lots 1 through 8, as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that

said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; that said Council has rejected a portion of Lot 6 marked "Reserved for Future Street;" that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities and slope rights, as well as the open space easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
