which is on file in the office of the City Clerk as Document No. RR- 258536 3, quitclaiming to TREETOPS UNLIMITED, a joint venture, all of the City's right, title and interest in the drainage easement in Parcel 1 of Parcel Map 10018, as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
