RESOLUTION NUMBER R- 258541

Adopted on MAY 31 1983

WHEREAS, DAVID G. PRICE has requested an exchange of drainage easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are approximately equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of DAVID G. PRICE, executed in favor of The City of San Diego, bearing date of January 3, 1983, conveying to said City a drainage easement in a portion of Lot 4 of Penasquitos Unit No. 2, Map No. 5599, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258541-1, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258541-2, quitclaiming to DAVID G. PRICE, all of the City's right, title and interest in the drainage easement in a portion of Lot 4 of Penasquitos Unit No. 2, Map No. 5599, as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to deliver both deeds, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
