
Adopted on MAY 31 1983

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to accept the proposal of CONROCK CO. dated February 28, 1983, pursuant to which Conrock will excavate, remove and market existing sand and deepen an existing debris basin from ten to twenty feet and excavate within the existing flood control channel to a depth of five feet and a width of thirty feet, all in the area of the San Pasqual Vineyard leasehold, and pursuant to which proposal Conrock will pay 80.2 cents per cubic yard of sand removed, under the terms and conditions of that proposal on file in the office of the City Clerk as Document No. RR- 258549, and in accordance with such other terms and specifications as may be required by the City Manager.

BE IT FURTHER RESOLVED, that the City Council hereby authorizes the payment of one-half of the amount received by the City from Conrock to the San Pasqual Vinyards' lessee since all of the sand removal will take place within the San Pasqual Vinyards' leasehold.
