RECONSTRUCTION - MESITA DRIVE TO 650 FEET SOUTHEAST, San Diego, California

filed in the office of the City Clerk of the City of San Diego, California, on MAY 31 1983, and bearing official Document No. R-258552, be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

MAINTENANCE SURFACING VARIOUS CITY STREETS - GROUP "S" AND 63RD STREET PAVEMENT

RECONSTRUCTION - MESITA DRIVE TO 650 FEET SOUTHEAST.

BE IT FURTHER RESOLVED, that the combined total expenditure, not to exceed \$2,504,079.00 as follows: \$2,134,079.00 from Gas Tax Fund 30219; \$260,000.00 from Water Utility Operating Fund 41500; and \$110,000.00 from Sewer Revenue Fund 41506, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
