## RESOLUTION NUMBER R- 258555 Adopted on MAY 3 1 1983

WHEREAS, Section 8330, et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets and public service easements by City Council resolution; and

WHEREAS, in connection with said vacation the City desires to reserve a certain easement; and

WHEREAS, the abutting property owner has requested the vacation of portions of Complex Street, Topaz Way, and the street reservation adjacent to Parcel 2 of Parcel Map 11434, to unencumber his property from existing encroachments; and

WHEREAS, the portions of Complex Street and Topaz Way adjacent to Parcel 2 of Parcel Map 11434, are excess right-of-way and no longer needed for present or prospective public use; and

WHEREAS, that portion reserved for future street adjacent to Parcel 2, Parcel Map 11434, adjacent to the Complex Street/
Topez Way intersection is no longer needed for present or prospective public use; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That those portions of Complex Street, Topaz Way, and that portion reserved for future street adjacent to Parcel 2 of Parcel Map 11434, as more particularly shown on Drawing No. 15845-B, on file in the office of the City Clerk as Document No. RR-25255. which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That The City of San Diego hereby reserves and excepts the right, easement, and privilege of placing, constructing, repairing, replacing, maintaining, using, and operating public utilities of any kind or nature, including, but not limited to, sewer and water utilities and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along, and across the hereinafter-described easement, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon acquisition of encroachment permit from the City Engineer pursuant to the Municipal Code of the City, the owners of the underlying fee may utilize the above-described parcel of land for structures, the planting or growing of trees, or the installation of privately owned pipelines.

- 3. That the easement reserved herein is in, under, over, upon, along, and across Complex Street and Topaz Way adjacent to Parcel 2 of Parcel Map 11434, vacated by this document and as more particularly shown on Drawing No. 15845-B, on file in the office of the City Clerk as Document No. #258555.
- 4. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.




