


RESOLUTION No. R- 258589 (R-83-1813)

That the bid of LA MESA SHEET METAL WKS. INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for CONVERTING AND REFURBISHING ONE (1) 1969 AMERICAN LA FRANCE APPARATUS for a total cost of \$62,827.20, plus applicable sales tax of \$3,724.92 less credit for salvage boom and basket assemblies rear body compartmentation and tandem axle assembly in the amount of \$2,500.00; terms net 30 days, with an option to convert one to two identical units by September 30, 1983 at a cost not to exceed 10% of price bid.
