RESOLUTION NUMBER R- 258595

WHEREAS, several organizations and individuals within the City of San Diego have expressed their support of the Police Department in the form of sizeable donations for the purchase of specialized equipment or for unique training opportunities; and

WHEREAS, it is anticipated that there are other individuals and organizations who would like to donate funds or items of equipment to the City and earmark these donations specifically for the Police Department; and

WHEREAS, it is deemed desirable to establish a special fund in which such donations may be placed; and

WHEREAS, it is anticipated the creation of such fund would be widely publicized and included as one form of donation in the forthcoming City catalog; and

WHEREAS, monies in such fund would be disbursed upon approval of the City Council after specific recommendation by the City Manager upon advice of the Chief of Police; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized and directed to establish a special fund entitled "San Diego Police Department Special Fund" for the purpose of serving as a repository of monies donated to the City by individuals and organizations, said monies to be used for Police Department purposes as authorized by the City Council.

BE IT FURTHER RESOLVED, that the City Manager, in cooperation with the Chief of Police and City Auditor and Comptroller, is directed to establish policies and procedures for the receipt, accountability and expenditure of said monies.
