
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. DENARDI & WOOD, 2. BEBCO, and 3. CONDOR CARRIAGE COMPANY are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of VARIOUS TRUCK BODIES as follows:

1. DENARDI & WOOD for Section I - ten (10) each, 1½ cubic yard Dump Bodies at a cost of \$2,886.00 each, for a total cost of \$28,860.00; terms 1% 20 days, plus sales tax.
2. BEBCO for Section II - two (2) each, 8 cubic yard Dump Bodies at a cost of \$5,785.00 each, for a total cost of \$11,570.00; terms net 10 days, plus sales tax.
3. CONDOR CARRIAGE COMPANY for Section III - five (5) each, Utility Bodies at a cost of \$1,624.00 each, for a total cost of \$8,120.00; terms net 30 days, plus sales tax.
