RESOLUTION NUMBER R- 258629

WHEREAS, on May 18, 1983, the Public Facilities and Recreation Committee approved by a 3-0 vote to approve a waiver of a portion of the rental fee for use of Plaza Hall for the third annual City Employee Blood Drive to be conducted on July 7, 1983; and

WHEREAS, the Blood Drive will be sponsored jointly by the City and the San Diego Blood Bank; and

WHEREAS, the Blood Bank will pay the City's actual out-of-pocket costs of \$188 and the remainder of the rental fee, \$257, is proposed to be waived; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to waive a portion of the rental fee in the amount of \$257 for use of Plaza Hall by the San Diego Blood Bank for the purpose of conducting the third annual City Employee Blood Drive on July 7, 1983.

BE IT FURTHER RESOLVED, that the City declares its co-sponsorship, with the San Diego Blood Bank, of the blood drive.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$257 from the

General Fund 100, Unallocated Reserve (605) to the Convention
and Performing Arts Center Fund for the defrayal of said rental
fees.
