BE IT RESOLVED, by the Council of The City of San Diego as follows:



BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer funds in the amount of \$1,000 from PSD Fund No. 11730 to CIP No. 29-457.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$1,000 each from CIP No. 23-711.1, La Jolla Lifeguard Office and Garage, CIP No. 23-600.1, Ocean Beach Recreation Center Improvements and CIP No. 29-457, South Bay Park and Recreation Center Gym Floor, a total of \$3,000, is hereby authorized, for the purpose of financing the First Amendment to Agreement.
