That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with San Diego Opportunities Industrialization Center to provide a special training and placement service and a career training and enrichment program for seventeen eligible youths at a total cost of \$20,000, as part of the Regional Youth

Employment Program (REGY) Summer Program, under the terms and conditions set forth in the agreement on file in the office of the City Clerk Document No. RR- 258635-3.
