Adopted on JUN 13 1983

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute an amendment to the 1983 contract between The City of San Diego and the Regional Employment Training Consortium, on file in the office of the City Clerk as Document No. RR-257921, increasing the total funding level for the 1983 Summer Youth Employment Program from \$1,922,381 to \$2,676,120 and increasing the number of eligible youth participants from 1,275 to 1,800.


2. That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City, an amendment to the agreement between The City of San Diego and the San Diego Unified School District, on file in the office of the City Clerk as Document No. RR-258392-8, increasing the compensation for the 1983 Summer Youth Employment Program from \$40,233 to \$60,377.

3. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with San Diego Opportunities Industrialization Center to provide a special training and placement service and a career training and enrichment program for seventeen eligible youths at a total cost of \$20,000, as part of the Regional Youth

Employment Program (REGY) Summer Program, under the terms and conditions set forth in the agreement on file in the office of the City Clerk Document No. RR- 258635-3 .
