Steven Gates Kenneth Martinosky	General Services	\$ 205	Mr. Gates and Mr. Martinosky are Equipment Mechanics in the Equipment Division. They suggested a modification to the dempster packing cylinder ram shaft. This is expected to save \$1,364 in the first year in time and material costs. This is a partial award pending a final 12 month review.
Janice Love	Water Utilities	\$ 185	Ms. Love is an Intermediate Typist in the Systems Division. She suggested that the Lakes Recreation Program be printed. This is expected to save \$1,213 in the first year in material costs. This is a partial award pending a final 12 month review.
Bobbie L. Nichols	General Services	\$ 170	Mr. Nichols is a Painter in the Buildings Division. He suggested that a policy be established to have Frazee Paint supply Mineral Spirits and Lacquer Thinner to the City. This is expected to save \$1,135 in the first year in time, material and equipment costs. This is a partial award pending a final 12 month review.
James K. McCormick	General Services	\$ 110	Mr. McCormick is a Building Manager in the Buildings Division. He suggested that the light fixtures by the paint booth in the Police Garage be eliminated. This is expected to save \$369 in the first year in equipment and energy costs.
