Maria V. Romero Clarence Haseyama	Auditor	Category III \$ 90 Category II \$ 50 Merchandise Award	Ms. Romero is a Clerk and Mr. Haseyama is an Accountant II. They suggested that the "Equipment Number Envelope" be revised. This is expected to save \$606 in the first year in costs for time.
William J. Jarvis	General Services	\$ 50	Mr. Jarvis is a Sanitation Driver II in the Solid Waste Division. He suggested that the convex rear view mirror on the Crane one man trash trucks be replaced. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Robert J. Terrien	Fire	\$ 30	Mr. Terrien is a Firefighter. He suggested that supplying salt tables be eliminated. This is expected to save \$100 in material costs.
Dennis C. Schmitz	Fire	\$ 25	Mr. Schmitz is an Engineer. He suggested that the Incident Report form be revised. Although savings were difficult to identify, this was considered to be a significant operational improvement.
