CITY WIDE 1983.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245, \$65,000.00 from CIP No. 62-002 MINOR SIGNAL IMPROVEMENTS and \$40,000.00 from CIP No. 61-001 SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN CHANGES IN TRAFFIC PATTERNS/VOLUMES to CIP No. 62-001 HIGH ACCIDENT LOCATIONS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$170,000.00 from Capital Outlay Fund 30245, CIP No. 62-001 HIGH ACCIDENT LOCATIONS, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
