APPROVING MAP OF MIRA WOODS VILLAS.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Bruce H. Wyman, a registered civil engineer, entitled "MIRA WOODS VILLAS, being a subdivision of a portion of the west half of the southwest quarter of Section 32, Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to Official Plat thereof, together with portions of Maya Linda Road and Gold Coast Drive, as vacated to public use and together with portions of Maya Linda Road and Gold Coast Drive, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Maya Linda Road; and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the


construction and maintenance of sewer and drainage facilities,  
as granted and shown on said map and subject to the conditions  
set forth thereon.

The Clerk of said City is hereby authorized and directed to  
endorse upon said map, as and for the act of the Council, that  
said Council has approved said subdivision map and that said  
portion of a public street is accepted on behalf of the public  
as heretofore stated, together with the easements with the right  
of ingress and egress for the construction and maintenance of  
sewer and drainage, as granted and shown on this map within this  
subdivision, is accepted on behalf of The City of San Diego, a  
municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said  
map to the Clerk of the Board of Supervisors of the County of  
San Diego, California.
