BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of GENSTAR DEVELOPMENT INC., a New York corporation, executed in favor of The City of San Diego, bearing date of February 11, 1983, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 258682, granting to said City an easement for public street purposes in a portion of Quarter Section Lots 53 and 54, Rancho De La Nacion, Map No. 166, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and Parcel "A" is hereby named WOODMAN STREET, Parcel "B" is hereby named BULLOCK DRIVE, and Parcel "C" is hereby named WINDWARD STREET.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
