WHEREAS, The City of San Diego is the owner of a general utility easement affecting Lot D of Block 5, Las Alturas No. 2, Map 1866; and

WHEREAS, the easement has never been used and the City has no present or prospective use for the easement; and

WHEREAS, the Engineering and Development Department has recommended that the City quitclaim to CONRUBA, a California general partnership, its interest in and to the easement; and


WHEREAS, the quitclaim of the easement will allow maximum utilization of the land; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258683-1, quitclaiming to CONRUBA, a California general partnership, all the City's right, title and interest in the general utility easement, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to cause the deed, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
