WHEREAS, the California Department of Transportation ("CALTRANS"), has established a process for the preparation of a Project Authorization Report; and

WHEREAS, the City's adopted North University City Community Plan proposes construction of a partial interchange on Interstate 5 at Nobel Drive; and

WHEREAS, Genstar Development Inc. has offered to convey the sum of \$10,000 which will defray CALTRANS costs in conducting the requested Project Authorization Report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby requests that CALTRANS initiate a Project Authorization Report for the evaluation of the construction of a partial interchange on Interstate 5 at Nobel Drive.

BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute an agreement with Genstar Development Inc., a copy of which is on file in the office of the City Clerk as Document No. RR-258690. Said agreement accepts the \$10,000 offered by Genstar Development Inc. for the sole purpose of transferring said funds to CALTRANS for the purpose of funding the CALTRANS study for the construction of a partial interchange on Interstate 5 at Nobel Drive.
