RESOLUTION NUMBER R-258696

Adopted on JUN 20 1983

WHEREAS, California law currently prohibits local agencies from levying or collecting an income tax on its residents; and

WHEREAS, there are, however, eleven states that authorize local agencies to enact some form of a local income tax; and

WHEREAS, most of the states allow local jurisdictions to impose a tax that is below 4% of an individual's state income tax liability; and

WHEREAS, Senator Dills has introduced SB 23X and SB 979 to allow a board of supervisors or a city council to impose a personal income tax not to exceed 10% of an individual's state income tax liability if the proposed ordinance has been approved by a majority vote of the residents; and

WHEREAS, SB 979 is dormant while SB 23X is in the Assembly Revenue and Taxation Committee of the extraordinary session called to resolve the State's budget crisis; and

WHEREAS, on June 6, 1983, the Rules Committee considered the report and analysis provided by the Intergovernmental Relations Department (IRD) in Report No. 83-42 in which several issues were highlighted and a recommendation made therein; and

WHEREAS, the Rules Committee at that meeting recommended adoption by the City Council of a resolution expressing opposition to both SB 23X and SB 979; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that this Council does hereby express, for and on behalf of The
City of San Diego, opposition to SB 23X (Dills) and SB 979
(Dills).
